



Terms of use

1. The records at Deutsches Tagebucharchiv (DTA) are available for scientific and media purposes. The use of the materials may be limited and is subject to special regulations as agreed upon in the contract with the submitter or the author, to data protection, to copyright or to related rights.
2. A written request – either by email or postal mail – should include information on the subject of research and the intended use of the records in question. We will inform you whether suitable records are available and will provide abstracts from our database with keywords and a short summary (subject to a service charge).

The user can inspect the records in the reading-room of the DTA. After receiving the material the user is asked to check and ascertain its completeness and integrity. The documents must be handled with care and kept in the original order. Marking and underscoring parts of the text are not permitted and are considered damage for which the user will be held responsible.
If desired, the DTA can provide copies of the required records and mail them (subject to a fee).
3. The reproduction of complete records requires a special permission. The nature and the extent of the copies have to be negotiated with the DTA. The copies must not be used for any purpose other than previously defined. Passing on material to third parties is not allowed.
4. When using and reproducing records (text and images) held at the DTA, it is the user's responsibility to ensure that copyright, the protection of individual rights and the conditions of the contract with the submitter are not infringed. To ensure this the user must consult with the DTA which material may be published and which provisions related to the contract with the submitter must be observed.
In individual cases special agreements with the submitter or the author may be necessary.
Quoting from the DTA material in excess of the legal requirements of § 51 UrhG (Copyright Act) or using the material in a manner not agreed upon, require a written permission from the DTA.

The contractual provisions regarding the use of the material supplied by the DTA do not entitle the user to the same rights as conceded to the DTA by the submitter. The DTA is not obliged to confer to any third party the rights granted to the DTA by the submitter or the author.
By signing the form and obtaining the copies, the user becomes liable for any infringement related to the making of the copies or their use, unless an exception is granted or the user has the permission of the respective owner of the rights. The user is the only person responsible to the owner for the compliance with these rights and possibly for obtaining additional rights of use.

The DTA cannot be held responsible for any infringement of the rights of the user or of any third party. In the event the DTA is held liable by a third party for such an infringement, the user must exempt the DTA from these claims.
5. Whenever material from the DTA is reproduced, the DTA must be identified as its source and the document references must be indicated. (sample: DTA 1234, 4).
6. The DTA requests a sample copy of the scientific studies and publications that make, in any way, use of documents from the DTA collection.
7. The prices we charge are in keeping with the *DTA-Fees regulations* (current version) and cover the costs of our services.
